- Non- teaching staff





The committee will have the following functions.

1. To ensure the transparency of selection process.
2. To select students based on the predetermined criteria and available funds.
3. To determine the amount of the scholarship of each student.
4. To make necessary revisions to improve the effectiveness of the scholarship program.
5. to periodically review the Policy document and to make the necessary amendments to ensure the effectiveness of the scholarship programme

Selection Procedure

The Principal invites application for scholarships from the students. Scholarship Committee implement the scholarship selection process based on the financial needs of the UG and PG students of the college. and recommendations from teachers. The decision of the committee will be final and binding.
