- 2. AND WHEREAS, the institution, St. Joseph Training College for Women, Kovilvattom Road, Ernakulam, Cochin-682035, Kerala has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.
- 3. AND WHEREAS, on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 08.06.1999.
- 4. AND WHEREAS, the SRC has decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
 - The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31st July, 2015 failing which recognition will be withdrawn.
 - The Regional Committees shall inspect the proposed premises during August-September-October, Ш. 2015 and if on inspection it is found that the institution dose not fulfill required norms of infrastructure recognition will be withdrawn.
- Further, with regard to the second unit the institution shall create additional facilities that include (a) III. additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
