As per judgment read as 1<sup>st</sup> paper above in WP(C) No. 19776/2004 filed by the Manager, St. Joseph's Training College for Women, Ernakulam and three others, the Hon'ble High Court ordered that if such a representation with relevant documents is filed within one month from the date of the judgment, the first respondent Government should dispose of the same within three months after giving an opportunity of hearing to the petitioner and all affected parties. Accordingly, as per letter read as 2<sup>nd</sup> paper above, the petition of the Manager, Karmela Rani Training College, Kollam was received in Government requesting to sanction 1 full time post of Assistant Professor of Education and 1 part time post of Lecturer in Art Education. A petition of the manager, St. Joseph's Training College of Teacher Education for Women, Ernakulam was received requesting to sanction 1 more teaching post as per the NCTE norms vide letter read as 3<sup>rd</sup> paper above.

2. On the basis of the direction in the Judgment, all the four petitioners who are also the affected parties have been invited for a personal hearing on 11.4.2013. All except the Mount Carmel Training College, Kottayam attended the hearing. Fr.Joseph J., Principal in charge and Secretary, Managing Board, Karmela Rani Training College, Kollam informed that there are 7 optional subjects including commerce and 150 seats are allotted for the college. It is also informed that there are 11 sanctioned post of teachers in the college at present and the college needs one more permanent post of teacher to accommodate a commerce teacher so that the staff strength will be maintained. The request of Sr. Mary

Skaline, Manageress of St. Joseph College of Teacher Education for Women Ernakulam is to sanction one more teaching post urgently in addition to the present sanctioned strength of 15 in tune with the total student strength of 200. It is informed that as per the NCTE norms the college should have 14 teachers excluding Physical Education instructor and Principal. The request of Sri. Jose P. Mattam, Principal, St. Thomas College of Teacher Education, Pala is to sanction one more post of teacher in addition to the present strength of 12 in tune with the present sanctioned student strength of 150.

3. Government have examined the matter in detail. As per G.O.(MS) No.164/05/H.Edn dated 2.11.2005, the strength of teachers in 13 Training Colleges is seen enhanced to the strength as per the NCTE norms. Accordingly, one additional post of teacher was sanctioned to Karmela Rani Training College, Kollam and the total teacher strength became 11; five additional posts were sanctioned to St. Thomas College of Teacher Education, Pala and the total teacher strength became 12; six additional posts were sanctioned to St. Joseph College of Teacher Education for Women, Ernakulam and thus the total teacher strength became 15.

4. In the above circumstance, Government are pleased to sanction teaching posts as mentioned below and the judgment dated 27/11/12 in WP(C) No. 19776/04 is thus complied with.
